I hereby certify that I am the individual charged on the Georgia Uniform Traffic Citation, Summons, Accusation / Warning cited above and hereby petition the State Court of Chatham County to accept my plea of GUILTY in the above matter. I understand that each charge(s) cited above is/are misdemeanor(s) and that by pleading guilty to the charge(s), I am voluntarily giving up any Constitutional rights I have in the matter, which include the right to remain silent and the right to a trial by a judge alone or jury .

I acknowledge having been cited on **UNIFORM TRAFFIC CITATION/ACCUSATION**, as noted above, for violating the traffic law(s) of this State. **I PLEAD GUILTY** to the charge(s) and ask that the Court allow me to enter such plea and pay all fines and fees according to the Standing Order of the Court for such offense. I also agree to pay a service fee if, handled over the Internet, or EXACTLY the sum of the fines, fees and costs shown above, per the Courts Standing Order dated March 31, 2000.

I understand that the Court may accept my plea offer only if the charges shown above constitute each and every charge indicated in the citation and that there was no other incident or accident involved in the matter addressed herein. If accepted I agree to pay all associated fines, fees and costs, in full, by cash or credit card and that the Court will record the disposition of each charge shown, as required by law. **I understand that once all of the above is accomplished I will be excused from the State Court and no longer required to appear on this matter.**

Accordingly, I hereby present my answers to the Court for the following questions, as a matter of record:
